● Everything You Need to Know:

A party coordinator will be assigned to your party.

Food orders must be given to the Lighthouse Cove Party Planner upon arrival of all party guests.

All necessary paper goods are supplied.

A birthday cake or cupcakes are the only outside food allowed at Lighthouse Cove. No additional outside food or drinks are permitted.

Any special requests need to be approved by a supervisor. Special request may include anything not specifically covered in this agreement.

The behavior of the children participating in the party is the responsibility of the host/hostess. Parents/Adults are responsible for the supervision of their children at Lighthouse Cove. It is not the responsibility of the party planner coordinator to supervise the party guests while on the golf course

Our basic rate includes the use of the pavilion space and mini golf courses at Lighthouse Cove, plus a party coordinator who will lead the activities and help you with pre-party setup and post-party cleanup. Pre-party setup time [limited to 30 minutes] and post-party cleanup time [limited to 30 minutes] does not count toward your 2 hours.

A \$200 non-refundable deposit is due when booking a birthday party. A remaining balance is due the day of your party.

All events require a **15% service charge**, this is not a tip. A service charge is set for parties for our staff and facilities so that we can accommodate you and exert the additional service needed to provide your group an exceptional experience.

State **Sales Tax of 7%** (or current rate at time of event) will be added to all food, beverage, pavilion rentals and services provided by Lighthouse Cove and the Burger Shack in accordance with Florida State Laws.

Although we do not add a gratuity to parties, please note that the **service charge is not a tip** to be allocated to the staff that assists with your party. We leave it to **your discretion** to add a gratuity that is on par with the level of service that you have been provided!
